

**MINUTES
EAST NOTTINGHAM TOWNSHIP
PLANNING COMMISSION MEETING
DECEMBER 20, 2004**

The Regular Meeting of the East Nottingham Planning Commission was held in the Township Building on December 20, 2004. Those present were: Chairperson Marianne Russo, Vice-Chairman Joseph R. Bauer, Alvin Miller, Clifford Lee, Michael Rebert, Zoning Officer Andrea Hingley, Secretary Pat Brady and numerous guests.

The Meeting was called to order at 7:05 p.m. by Chairperson Marianne Russo.

The Pledge of Allegiance was led by Vice-Chairman Bauer.

Motion made by Vice-Chairman Bauer seconded by Clifford Lee to approve the agenda for the Meeting with the following changes: taking off the Noise Ordinance and also adding under Subdivision/Land Development Plans, making it #4 Doolittle/Shepherd Property, therefore changing Woods at Nottingham to #5 and so on.

Act 537 Status- Ron Ragan- There was a meeting with a representative from DEP and a representative from each municipality the week of December 13, 2004 to discuss what direction to take at this time. There is another meeting scheduled on 2/5/05. Per Ron Ragan, there is a 40 acre minimum to have cluster housing with sewer. Ron will have more information concerning this at the January Planning Commission Meeting.

Public/Ground Water Ordinance (Walt Leis)- We are developing an Ordinance that allows the Township to have greater oversight of the Township's water supply. This Ordinance was put together primarily to develop ground & surface resources for water that needs to be protected. It will give the Township some control, which they do not have now.

Barness Organization- A presentation of a prepared layout for 120 units for a by right conventional subdivision, cluster zoning with off site sewer & water on approximately 197 acres. Chairperson Russo suggests that, in mid January 2005 the Planning Commission will set up an appointment to discuss this again in more detail.

After some discussion a motion was made by Chairperson Russo seconded by Michael Rebert to grant a waiver to 502.16A, locate the driveway for Lot 33 less than 80 feet from Century Oak Drive but no less than 50 feet from Century Oak Drive.
